3. We (I) agree to pay all reasonable attorney's fees, court fees and other costs that could be incurred by BSS ECC and Temple in attempting to collect delinquent payments.
4. We (I) give our consent and permission for our (my) child to participate in all activities offered at the BSS ECC and Temple site.
5. We (I) hereby agree to abide by all policies set by BSS ECC and Temple. We (I) further agree to accept the rules and regulations of BSS ECC and Temple as they now exist or may from time to time be altered or amended.
